

SLINGER UTILITIES - NOTICE OF CHANGE

Beginning in JUNE 2023, Slinger Utilities will be changing the billing date and due date for its customers. This billing date change will give utility workers more days per month to complete necessary work. This will also keep our retail electric sales to customers in alignment with our wholesale electric purchases from WPPI, which will continue to minimize the monthly Power Cost Adjustment Clause (PCAC) charges to customers. The Power Cost Adjustment Clause (PCAC) allows electric utilities to make monthly adjustments to customer bills when costs for providing power are above or below the average cost authorized by the Public Service Commission (PSC).

PREVIOUS BILLING PROCEDURE

The wholesale bill for electric was received by the 6th of each month, which covered the prior month's consumption. Customer meters were read as close to the 1st of each month as possible, give or take a couple days. Utility bills were mailed no later than the 20th of each month with payments due by the 10th of the following month.

NEW BILLING PROCEDURE

We will continue to receive our wholesale electric bill by the 6th of each month. Customer meters will continue to be read as close to the 1st of each month as possible, give or take a couple days. Utility bills, however, will be mailed by the 8th of each month and the due date will now be the 28th of the current month. ***Note that JUNE will have two bills DUE that month,*** indicated in red below.

ACH CUSTOMERS – THIS HAS CHANGED SINCE THE FIRST NOTIFICATION!

The shift of the billing date will also affect the date of ACH customer withdrawals. Scheduled ACH payments will now be on the **REGULAR DUE DATE** each month instead of the 5th, beginning in JUNE. ***There will be two ACH withdrawals in JUNE.*** If you would like to withdraw from the ACH program, please notify us at 262-644-5265 by May 26, 2023. This will require that you pay your utility bill in another manner.

MyACCOUNT AUTO-PAY CUSTOMERS

Please note that the June 8th bill will be generated prior to the June 10th due date for May's bill. This will cause a higher-than-normal total account balance from June 6th through June 10th. If you are scheduled for auto-pay during that time, ***the entire account balance will be paid.*** Slinger Utilities suggests that you make a manual payment prior to June 6th if you wish to only pay the May 20th bill, and then adjust your auto-pay for the June 23rd due date and beyond.
