The undersigned, being first duly sworn, states that:

Count 1: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on or about August 23, 2022, in the Town of Hartford, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess recording with MD5 value: d506571cfd676ed3a1daaec62a9e5e45 of a child engaging in sexually explicit conduct, and reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years.

Count 2: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on or about August 23, 2022, in the Town of Hartford, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess recording with MD5 value: 2b1e0614c49808d0144b64dfd8269cf1 of a child engaging in sexually explicit conduct, and reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years.

Count 3: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on or about August 23, 2022, in the Town of Hartford, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess recording with MD5 value: 943a294d14ff62307f8a2b9329ebf4d3 of a child engaging in sexually explicit conduct, and reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years.

Count 4: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on or about August 23, 2022, in the Town of Hartford, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess recording with MD5 value: 2EC036FF81EFFDF3BE2CACA626BA336E of a child engaging in sexually explicit conduct, and reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years.

Count 5: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on or about August 23, 2022, in the Town of Hartford, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess recording with MD5 value: 31D650DD1B782B142B1E519969BC5723 of a child engaging in sexually explicit conduct, and reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years.

PROBABLE CAUSE:

Complainant prays that said defendant be dealt with according to law. The basis for the complainant's charge of such offense is he is a sworn officer with the Washington County Sheriff's Office and bases his information upon review of the report of Detective A. Conforti of the Washington County Sheriff's Office, who reports on August 23, 2022, that he assisted the Dodge County Sheriff's Office with the execution of a search warrant at in the Town of Hartford, Washington County, Wisconsin. Detective Conforti reports that Dodge County Sheriff's Office Detective M. Lake had been investigating Jeffrey John Feistel, the defendant herein, for uploading images of a female to a pornography website without her permission. Detective Lake subsequently applied for and was granted a search warrant for Jeffrey's residence located in the Town of Hartford, which included the seizure of all computers, computer hardware devices, and digital/electronic storage devices. Detective Conforti reports that he as well as two other Washington County Sheriff's Office detectives and members of the Dodge County Sheriff's Office executed the search warrant. Detective Conforti reports that the following day, he was contacted by Detective Lake and advised that the investigation would be turned over the Washington County due to jurisdictional issues.

Detective Conforti reports that on August 29, 2022, he received the reports completed by Detective Lake. Said officer reports that he reviewed Detective Lake's reports and noted that Detective Lake located items believed to constitute child sexual abuse material (CSAM) and child erotica. Due to the suspected CSAM that Detective Lake located, Detective Conforti completed the necessary affidavits and search warrants for the electronic devices seized from the defendant. Said officer reports that due to the high likelihood of CSAM located on the devices, he completed a request for transmittal of criminal evidence form for the devices to be forensically analyzed by the Wisconsin Division of Criminal Investigations (DCI) in September of 2022. Those devices were subsequently turned over to the Wisconsin Department of Justice – DCI Digital Forensics Unit for analysis. On July 17, 2023, said officer was contacted by DCI Digital Evidence Unit Manager M. Olesen, who advised that the electronics were being

transferred from the Milwaukee Field Office to the Appleton Field Office due to the substantial backlog at the Milwaukee Field Office.

Detective Conforti reports that on December 8, 2023, he was advised that all submitted evidence had been analyzed with the exclusion of an LG cell phone with a defective screen. Said officer reports that on December 13, 2023, he received a flash drive containing all of the extraction data as well as an examination report from Digital Evidence Specialist C. Byars. Said officer reports that DES Byars' report provided two categories of materials, one containing CSAM and the other with child exploitation material where the ages of the children are indeterminate or the depictions do not meet the statutory definition of child pornography.

Detective Conforti reports that his review of the CSAM material identified by DES Byars included the following:

As to Count 1:

File Name: Best Vicky BJ & Handjob. 1.1 mpg

MD5 Hash Value: d506571cfd676ed3a1daaec62a9e5e45

The recording was located on the defendant's Sandisk Cruiser 16GB flash drive that was originally located underneath his mattress in his bedroom. The recording is 15 seconds in length, and it depicts a prepubescent female with no shirt, lying between the unclothed legs of an adult male. The prepubescent female has medium-length brown hair and no breast development. The prepubescent female has both of her hands around the male's erect penis and is performing oral sex on the adult male's penis.

Furthermore, the MD5 Hash Value indicated above was queried through the National Center for Missing & Exploited Children (NCMEC) law enforcement portal which yielded that the hash value was recognized as being previously submitted to the child identification and recognition system.

As to Count 2:

File Name: Buttfuck Dildo.mpeg

MD5 Hash Value: 2b1e0614c49808d0144b64dfd8269cf1

The recording was located on the defendant's SanDisk Cruzer 16GB flash drive that was originally located underneath his mattress in his bedroom. The video is 20 seconds in length, and it commences with a black screen and blue writing saying "Double Duty 2". The recording depicts a zoomed-in screen of a prepubescent female penetrating her anus with her index and middle finger while she is bending over. The recording transitions to an adult male inserting his erect penis into the prepubescent female's anus while she is on top of him facing the camera, exposing her vagina. The prepubescent female does not have any pubic hair. The male's hand is grasping his erect penis, and his hand is greater than half the size of the prepubescent female's buttocks. While the male has his erect penis inserted into the prepubescent female's anus, the female inserts a pink dildo into her vagina with her right hand until the recording ends.

As to Count 3:

The image was located on the defendant's SanDisk Cruzer 16GB flash drive that was originally located underneath his mattress in his bedroom. The pixelated image depicts a prepubescent female with long dark hair standing over an adult male's legs, leaning toward the male's abdomen with her face directly next to the male's erect penis. The image is taken from the angle of the male's face and is directed toward his legs. The prepubescent female is smiling at the camera and has what appears to be a fluid consistent with semen dripping from her mouth onto the male's erect penis. The juvenile has a small bone structure and what appears to be no breast development, consistent with a prepubescent female.

As to Count 4:

MD5 Hash Value: 2EC036FF81EFFDF3BE2CACA626BA336E

The image was located on the defendant's KIK application that was on his cellular device which was secured with a passcode that only he uses. The image depicts a nude (except for wearing shoes) adult male standing with an erect penis. There is a nude prepubescent female kneeling on the ground with the adult male's penis in her mouth. The image was taken from the male's right side, and the prepubescent female's left side at approximately the chest height of the male angled down toward the prepubescent female. The male is identified as an adult based on his large stature, bone structure, body hair, and large stomach. The prepubescent female is without breast development, has a small stature, and small bone structure, especially in comparison to the male.

As to Count 5:

File Name: aa3db740-2d8d-4d64-96c3-98a77b5d71c6

MD5 Hash Value: 31D650DD1B782B142B1E519969BC5723

The recording was located on the defendant's KIK application that was on his cellular device which was secured with a passcode that only he uses. The recording is 1 minute and 24 seconds in length. It depicts a prepubescent Caucasian female, with blonde hair wearing a white t-shirt. The prepubescent female is on her knees facing an adult male, who is standing with his erect penis protruding through the "fly" in his blue underwear. The adult male is wearing pants or shorts that are unbuttoned and positioned below his waist. The prepubescent female performs oral sex on the male's erect penis by repeatedly moving her head back and forth. At times, the male is placing his right hand on the back of the female's head and forcefully moving her head back and forth while her mouth is around his erect penis. While the male is doing this, the prepubescent female begins to gag and cough until the erect penis is removed from her mouth. The male then begins masturbating himself. The male masturbates for approximately 8 seconds while the prepubescent female speaks a language that sounds other than American English. The prepubescent female then continues to perform oral sex on the adult male in addition to using her right hand to stroke the male's erect penis. The female's lack of breast development, small bone structure, and small hand size are consistent with that of a prepubescent female.

Detective Conforti further reports that on December 18, 2023, he and Detective T. L'Allier responded to the defendant's place of employment located on the in Clintonville, Wisconsin. The defendant was located and agreed to go to the Clintonville Police Department to discuss the pending investigation. Said officer reports that the defendant

provided statements that your complainant believes to be reliable as they are statements contrary to his penal interests. After being advised that the devices seized by the Dodge County Sheriff's Office were analyzed and contained a large quantity of pornography, including child pornography. The defendant admitted that he previously had what he described as a pornography addiction and viewed it on chatpic.org. The defendant stated that chatpic offers "15 minute rooms" which allow any user to create a room/forum to share, upload, and comment on images or videos relating to the title of the room. The defendant stated that after fifteen minutes, the room would be deleted or inaccessible. He described that the rooms could also be public or require a password for access from the room creator. The defendant stated that the rooms could contain a variety of contents, including "questionable stuff" where he could tell the females were "thirteen or younger." The defendant stated that when he located material with girls younger than thirteen, he would leave the room. He also stated that he did not knowingly download files of children. The defendant stated that he would download content and place it onto a flash drive so he could view it later.

Detective Conforti reports that he showed the defendant sanitized images taken from Counts 1-5. The defendant stated, "If it's on there, its on there. But I'm telling you this is not stuff I am seeking out." The defendant stated that these images could have come from a large download he completed from a room. When asked why some of the images were on the flash drive under his mattress, the defendant stated, "Some of the I'm sure were on there, where I got them I am not 100% sure." He also stated if the flash drive was underneath the mattress that it would not be his primary device and that he would not be looking at the images often.

Based on the foregoing, the complainant believes this complaint to be true and correct.
