**CRIMINAL COMPLAINT**

The undersigned, being first duly sworn, states that:

**Count 1: 2ND DEGREE SEXUAL ASSAULT OF A CHILD UNDER 16 YEARS OF AGE - PTAC, AS A PARTY TO A CRIME** (As to defendants Todd Allen Blehovde and Amy Anne Carlson)

The above-named defendants on or between January 1, 2021 and January 1, 2022, in the Village of Slinger, Washington County, Wisconsin, as a party to a crime, did have sexual contact with a child under the age of sixteen, VICTIM, under the age of 16, contrary to sec. 948.02(2), 939.50(3)(c), 939.05 Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 2: 2ND DEGREE SEXUAL ASSAULT OF A CHILD UNDER 16 YEARS OF AGE** (As to defendant Todd Allen Blehovde)

The above-named defendant on or between January 1, 2021 and January 1, 2022, in the Village of Slinger, Washington County, Wisconsin, did have sexual intercourse with a child under the age of sixteen, VICTIM, under the age of 16, contrary to sec. 948.02(2), 939.50(3)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 3: FAILURE TO PROTECT A CHILD** (As to defendant Amy Anne Carlson)

The above-named defendant on or between January 1, 2021 and January 1, 2022, in the Village of Slinger, Washington County, Wisconsin, as a person responsible for the welfare of a child under the age of sixteen, VICTIM, under the age of 16, with knowledge that a person is having sexual contact with said child, did fail to take action to prevent the sexual contact and created an unreasonable risk of the sexual contact occurring, contrary to sec. 948.02(3), 939.50(3)(f) Wis. Stats., a Class F Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

**Count 4: SEXUAL INTERCOURSE WITH A CHILD** (As to defendant Todd Allen Blehovde)

The above-named defendant on Saturday, February 17, 2024, in the Village of Slinger, Washington County, Wisconsin, did have sexual intercourse with a child, VICTIM, 16 years of age, who was not his spouse and who had attained the age of 16 years, and the actor had attained the age of 19 years, contrary to sec. 948.09, 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 5: CHILD ENTICEMENT - PTAC, AS A PARTY TO A CRIME** (As to defendants Todd Allen Blehovde and Amy Anne Carlson)

The above-named defendants on or between January 1, 2021 and January 1, 2022, in the Village of Slinger, Washington County, Wisconsin, as a party to a crime, with intent to have sexual contact with the child in violation of Section 948.02, Wis. Stats., did cause a child, VICTIM, under the age of 16, who had not attained the age of 18 years to go into a room, contrary to sec. 948.07(1), 939.50(3)(d), 939.05 Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

**Count 6: TRAFFICKING OF A CHILD** (As to defendant Todd Allen Blehovde)

The above-named defendant on or between January 1, 2021 and January 1, 2022, in the Village of Slinger, Washington County, Wisconsin, did knowingly solicit a child for the purpose of commercial sex act, contrary to sec. 948.051(1), 939.50(3)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 7: BENEFIT FROM TRAFFICKING OF A CHILD** (As to defendant Amy Anne Carlson)

The above-named defendant on or between January 1, 2021 and January 1, 2022, in the Village of Slinger, Washington County, Wisconsin, did knowingly benefit in any manner from recruiting, enticing, providing, obtaining, harboring, transporting, patronizing or soliciting or knowingly attempting to recruit, entice, provide, obtain, harbor, transport, patronize or solicit any child for the purpose of commercial acts, as defined in section 940.302(1)(a) , contrary to sec. 948.051(2) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**PROBABLE CAUSE:**

Complainant prays that said defendant be dealt with according to law. The basis for the complainant's charge of such offense is he is a sworn officer with the Village of Slinger Police Department and bases this complaint upon his review of official police reports prepared by fellow sworn law enforcement officers.

Detective David Dudash reported that on February 27, 2024, he was assigned to investigate a report of child sex trafficking that had occurred in both the City of Milwaukee and the Village of Slinger. Detective Dudash reported that Milwaukee Child Protective Services ("CPS") Supervisor, Hannah Jungbluth stated that she was contacted by WITNESS who stated that sometime over the weekend of February 17, 2024 and February 18, 2024 her granddaughter, VICTIM, and VICTIM'S mother, Amy Anne Carlson, got into an argument over money. WITNESS stated that she asked VICTIM where she had gotten the \$70 from and VICTIM stated that she received the money from the pastor at church. WITNESS stated that Carlson

also stated that the money was received from the pastor and further told WITNESS to stop asking questions about the money. WITNESS stated that she telephoned the church pastor and was told that he had not given VICTIM any money. WITNESS stated that she questioned VICTIM again about the money at which time VICTIM stated that she would tell WITNESS as long as she did not get into trouble. WITNESS stated that VICTIM told her that Carlson was “trafficking” VICTIM in exchange for cash. WITNESS stated that VICTIM told her that a man named Todd would pick up VICTIM and Carlson and bring them to his trailer in Slinger where VICTIM and Carlson would perform sexual acts on Todd in exchange for money.

Detective Dudash reported that a forensic interview of VICTIM was conducted on February 28, 2024, at the Child Advocacy Center located at Sojourner Truth House in Milwaukee, Wisconsin. Detective Dudash reported that he was able to observe the interview from a separate room at that facility. Detective Dudash reported that the interview was conducted by Milwaukee CPS Forensic Interviewer Lauren Lycan. Detective Dudash reported that at the time of this investigation VICTIM was 16 years of age and during the interview it was established that VICTIM knew the difference between a truth and a lie and knew the importance of telling the truth.

### **2021 Offenses**

Detective Dudash reported that during the forensic interview VICTIM stated that she has been having sexual contact with a man whom she knows as Todd since 2021 when she was 13 years old. Detective Dudash reported that VICTIM was able to identify Todd by showing the interviewer Todd’s Facebook page where he uses the name of Todd Blehovde and an image of his face appears on the home screen for his account. Detective Dudash reported that he was able to obtain a Wisconsin Department of Transportation photo of Todd Allen Blehovde and he was able to positively match the Facebook photo as being the same person in the Department of Transportation photo identified as Todd Allen Blehovde.

Detective Dudash reported that during the forensic interview VICTIM referred to a penis as “that part” and referred to her own body’s vagina as “down there” or “princess parts”. Detective Dudash reported that VICTIM was able to provide a detail description of Blehovde’s truck including the fact that it was missing some door handles and contained a cooler with cigarettes and soda. Detective Dudash reported that officers subsequently located a vehicle which was found to be registered to Blehovde that matched the description provided by VICTIM and within which was a cooler found to contain cigarettes and soda.

Detective Dudash reported that VICTIM further stated that her mother is Amy Anne Carlson. VICTIM stated that her mother would originally go with Blehovde alone however in 2021 VICTIM began to go with Carlson and Blehovde to his trailer in Slinger and Carlson would then give her money to keep her quiet and to not tell her dad where they were or what they were doing. VICTIM stated that eventually Carlson would ask her to do things. VICTIM stated that Blehovde began making comments about VICTIM’S body and started touching VICTIM’S chest as well as other areas which she described as her “princess parts” and gestured to her frontal pubic area and later indicated that she meant her vagina.

Detective Dudash reported that VICTIM stated that in 2021 when she was 13 years old, while at Blehovde’s trailer in Slinger, Carlson made VICTIM undress in the kitchen so that both VICTIM and Carlson were naked. VICTIM stated that she gave Blehovde “hand jobs” and in exchange VICTIM was given a cell phone as well as snacks and food. Detective Dudash

stated that he is aware from his training and experience that “hand jobs” is a street term referring to an act of sexual gratification in which one person rubs the bare penis of another person. Detective Dudash reported that VICTIM stated that she did these things because she did not want to disappoint her mom (Carlson). VICTIM stated that Blehovde would not “come” (ejaculate) when she did things to him and her mother would then take over doing things to Blehovde until he did ejaculate. VICTIM stated that at times Carlson would praise her for doing such a good job on Blehovde because it then didn’t take Carlson as long to get Blehovde to ejaculate once Carlson took over. VICTIM stated Carlson would state, “you did such a good job I barely had to do anything.” VICTIM stated that on some occasions her mother would do sexual things to Blehovde while VICTIM waited on the couch. VICTIM stated that there were other times when she would do sexual things on Blehovde while all three of them (Blehovde, Carlson and VICTIM) were on the bed together and Carlson would teach VICTIM how to give Blehovde how to give a “hand job” by physically grabbing VICTIM’S hand and showing her how to do it and how to make it feel good. VICTIM stated that Carlson would watch VICTIM do “hand jobs” and “blow jobs” to Blehovde and then Carlson would do things sexually to Blehovde while VICTIM sat on the bed and watched. VICTIM stated that sometimes she would stay overnight alone with Blehovde in the trailer and during those times she would give him “hand jobs” and “blow jobs”. Detective Dudash stated that he is aware from his training and experience that “blow jobs” is a street term referring to an act of sexual gratification in which one person places their mouth on the penis of another penis.

Detective Dudash reported VICTIM stated that on one occasion when she was 13 years of age Blehovde did penetrate her anally with his penis and that it hurt and made VICTIM cry. Victim stated that on that occasion Blehovde picked her up in Milwaukee and brought her back to his trailer in Slinger alone. VICTIM stated that Blehovde had her lay on the bed with a pillow under her chest and stomach so her body was more raised up. VICTIM stated that Blehovde took out “lube” and put in himself and around her and in her anally and that this made her uncomfortable. VICTIM stated that she remembered that when he first put his penis into her anus that she bit down on the pillow really hard because it hurt. VICTIM stated that she let him do whatever he wanted to and the only thought going through her head was I’m doing this for mom because she wanted me to and that mom said we needed the money. VICTIM stated that Blehovde pulled her off the bed and then tried to again to put his penis into her anus but it hurt really bad and she started crying. VICTIM stated that Blehovde then told her to get dressed and drove her home. VICTIM stated that Blehovde gave her money and that she gave some of the money to her mom. VICTIM stated that she believes this occurred a short time after her brother’s birthday in 2021. Detective Dudash stated that VICTIM’s brother’s birthday is on February 10<sup>th</sup>.

Detective Dudash reported that VICTIM stated that Blehovde gave her approximately \$50 each time she and Carlson came to Slinger. VICTIM stated that Carlson would ask VICTIM to give Carlson part of the money. VICTIM stated that she gave Carlson approximately \$5 to \$10 out of the money she was given by Blehovde. VICTIM stated that when Carlson would do sexual things to Blehovde, Blehovde would give Carlson \$50. VICTIM stated that Blehovde would pick up she and Carlson together or individually either in front of their old residence on 39<sup>th</sup> Street in the City of Milwaukee or on the corner nearby so that VICTIM’s dad would not see. VICTIM stated that on occasions when they did not go to Blehovde’s trailer in Slinger, they would find a dark, quiet place in the City of Milwaukee where they would give Blehovde “hand jobs” or blow jobs” inside Blehovde’s truck. VICTIM stated that sometimes she would go with Carlson to Blehovde’s trailer and she would not want to do anything but Carlson would

convince her to do things. VICTIM stated that sometimes Blehovde would take VICTIM shopping for bras, underwear and snacks. VICTIM stated that on one occasion when she slept overnight in Blehovde's trailer in Slinger, Blehovde sat in a recliner in the living room and VICTIM sat on the floor in front of him while Blehovde instructed her on how to do a "blow job." VICTIM stated that Blehovde asked her to see how long she could hold his penis in her mouth and further told her to "lick this area" while Blehovde pushed VICTIM's head up and down.

Detective Dudash reported that VICTIM stated that Carlson would set up the dates for both of them with Blehovde and that sometimes Carlson would use VICTIM's Facebook Messenger app to speak with Blehovde to set up the dates. VICTIM stated that Carlson and Blehovde would use the code words "clean" or "cleaning" when describing over Facebook the sexual activity.

Detective Dudash reported that VICTIM stated that the sexual assaults continued through 2021 and then stopped. Detective Dudash reported that VICTIM moved in that during that time frame VICTIM moved to a different residence in Milwaukee. Detective Dudash reported that VICTIM stated that no assaults occurred in 2022 and 2023.

### **February 2024 Offenses**

VICTIM stated that in February of 2024 Carlson told VICTIM to reach out to Blehovde. VICTIM stated that she reached out to Blehovde on Facebook Messenger. Detective Dudash reported that he examined the messages and observed that the messages to VICTIM came from an account in the name of Todd Blehovde and that the account contained a photo of the account holder. Detective Dudash stated that he can positively identify the person in the Facebook photo on that account as being Blehovde. Detective Dudash reported that the messages include Blehovde asking VICTIM, "what are you now, 15 almost 16?" and further asks VICTIM if she and her mom would be interested in cleaning his house again. Blehovde further asks VICTIM if she had any regrets. Detective Dudash reports that within the chats Blehovde arranged with to pick up VICTIM and bring her to his trailer in Slinger on February 11, 2024 and February 17, 2024. Detective Dudash reported that these arrangements appeared to have been facilitated through Carlson. Detective Dudash stated that Blehovde told VICTIM to tell Carlson what sexual things they did together and that Blehovde would check with Carlson to make sure VICTIM told her and that he wanted to know Carlson's reaction.

Detective Dudash reported that VICTIM stated that she was with Blehovde in his trailer on both February 11, 2024 and February 17, 2024 during which time she engaged in sexual acts with Blehovde in exchange for money.

Detective Dudash reported that VICTIM stated that on February 17, 2024, Blehovde brought VICTIM to his trailer in Slinger and made her get undressed. VICTIM stated that Blehovde placed pillows on the bed to prop her buttocks up higher in the air and then retrieved a bottle of "lube" from the drawer in a dresser next to the bed. VICTIM stated that Blehovde put the "lube" on his penis and on her buttocks and attempted to penetrate her anus with his penis. VICTIM stated that she jumped up and it stopped after which Blehovde stated, "I could tell you weren't ready." Detective Dudash reported that VICTIM provided a physical description of the lubricant and VICTIM stated that Blehovde told her that it was expensive. VICTIM stated that she believed it cost between \$30 to \$40. Detective Dudash reported that a search warrant was subsequently conducted at Blehovde's trailer at which time officers located a bottle of lubricant in the top nightstand drawer next to the bed, that matched the description provided by

VICTIM and officers noted that there was very little missing from the bottle and the bottle had a price tag of \$34.99.

Detective Dudash reported that VICTIM stated that since 2021 she estimates that she has been with Blehovde at his trailer in Slinger more than twenty times. Detective Dudash reported that VICTIM was able to provide a detailed description as to the directions to Blehovde's trailer in Slinger and as to the interior of the trailer. Detective Dudash reported that officers confirmed that Blehovde resides in a trailer located at [REDACTED] in the Village of Slinger, Washington County, Wisconsin. Detective Dudash reported that a search warrant was executed at that trailer and that the description of the travel path to the trailer as well as the interior of the trailer provided by the VICTIM was accurate. Detective Dudash further states that his investigation revealed that Blehovde currently resided alone in that trailer and had lived alone in that trailer for at least the last five years.

Detective Dudash reported that VICTIM stated that after CPS became involved in this offense Carlson told VICTIM to delete all her Facebook Messenger messages and further told VICTIM to deny that she knew someone named "Todd". Detective Dudash reported that VICTIM archived the messages and Detective Dudash was able to examine the messages which took place from February 9, 2024 through February 18, 2024.

Detective Dudash reported that on March 4, 2024 Blehovde was taken into custody outside his residence in the Village of Slinger. Detective Dudash stated that he did interview Blehovde regarding this offense and that during that interview Blehovde admitted that he met Carlson seven to eight years ago and that in approximately 2020 Carlson began coming to his residence in Slinger to clean and they engaged in a sexual relationship. Blehovde stated that the sexual relationship continued for approximately four years. Blehovde further admitted that he knew VICTIM. Blehovde stated that he would pick up both Carlson and VICTIM in Milwaukee and bring them to his residence in Slinger. Blehovde admitted that he on two occasions, once "a couple of years ago" and once in "the last month" he picked up VICTIM alone and brought her to his residence to Slinger to clean. Detective Dudash reported that prior to Detective Dudash asking any questions about sexual activity with the VICTIM, Blehovde stated that he did not have sex with VICTIM.

Based on the foregoing, the complainant believes this complaint to be true and correct.
