The undersigned, of the West Bend Police Department, being first duly sworn on oath, upon information and belief, states that:

Count 1: SEXUAL MISCONDUCT BY SCHOOL STAFF OR VOLUNTEER

The above-named Defendant, between March 24, 2024 and April 5, 2024, as a school resource officer, or a "school staff member" for purposes of this particular statute, did commit an act of sexual misconduct, namely verbal conduct of a sexual nature, against a pupil, Victim A, while Victim A was enrolled at that school, Kewaskum High School, and all of this occurred in Washington County, State of Wisconsin, contrary to sec. 948.098(2), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both, *a statute that went into effect on March 24, 2024*.

Count 2: MISCONDUCT/OFFICE-ACT/EXCESS AUTHORITY

The above-named defendant, between March 1 and April 5, 2024, the said Defendant, assigned to Kewaskum High School as a School Resource Officer, and acting in his official capacity as a School Resource Officer, did an act which the said Defendant knows is in excess of his lawful authority or which he knew was forbidden by law in his official capacity as a school resource officer when the said did pose in a mirror at that Kewaskum High School, taking pictures of himself in his official police uniform, while masturbating in the mirror and on those photos, contrary to sec. 946.12(2), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

Count 3: MISCONDUCT/OFFICE-ACT/EXCESS AUTHORITY

The above-named defendant, between March 1 and April 5, 2024, the said Defendant, assigned to Kewaskum High School as a School Resource Officer, and acting in his official capacity as a School Resource Officer, did an act which the said Defendant knows is in excess of his lawful authority or which he knew was forbidden by law in his official capacity as a school resource officer when the said defendant did approach Victim A, during the work day, in the theater costume closet, and tried to persuade Victim A, an 18 year old high school student, to engage in a "heavy make-out session", contrary to sec. 946.12(2), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

PROBABLE CAUSE:

And prays that the defendant be dealt with according to law; this complaint is based on the statements of Victims A, B and C, Witnesses A, B, C, and D, and the reports of the West Bend Police Department.

On April 5, 2024, the Kewaskum Police Department contacted the West Bend Police Department, and asked for assistance with a criminal investigation involving a member of that Kewaskum Police Department. The target of that criminal investigation was a recently promoted individual named Steven Rosales (DOB: 8/2/89 – hereinafter the Defendant) – recently promoted to a lieutenant. The West Bend Police Department accepted this request for an independent investigation, and members of that Department were assigned to immediately follow-up.

Interview of Witness B – Superintendent

That same afternoon, at around 3:15 PM, Lt. Lichtensteiger and Captain Grinwald spoke with Witness B – the superintendent of the Kewaskum School District. They learned from Witness B that a Kewaskum High School Staff Member informed him earlier in the day that a Kewaskum School Resource Officer – the Defendant – may have been involved in an improper sexual relationship with an 18 year old student there at Kewaskum High School. That 18 year old student was identified as Victim A. For purposes of this criminal complaint, Victim A was a full time enrolled student there at Kewaskum High School, or for purposes of this criminal complaint, a pupil.

Lt. Lichtensteiger and Captain Grinwald learned that a school staff member spoke with Victim B and Victim C – the parents of Victim A. Witness B learned that Victim A's parents had gone through her phone, and learned about a deeply troubling, potentially sexual relationship that Victim A had been having, over time, with that School Resource Officer, the Defendant.

Lt. Lichtensteiger and Captain Grinwald traveled to Victim A's home, located in Allenton, Wisconsin, and spoke with all three witnesses separately.

Interview of Victim C - Mom

Captain Grinwald spoke with Victim C. She said that her daughter is an 18 year old senior at Kewaskum High School. She said that her daughter turned 18 years old in December of 2023. Victim C said that their daughter does have some learning disabilities, and is on an Individual Education Plan (IEP) in school. She said that her daughter enjoys and is active in the high school theater, but that her daughter tends to be somewhat of an introvert, and doesn't have many close friends.

As a result, Victim C said that Victim A, towards the end of her junior year, ate lunch in the school resource officer's office. Victim C said that this is when her relationship with the Defendant began. Victim C said that Victim A would often talk about the Defendant, and Victim C believed (based on the way Victim A talked about him) that the Defendant was a good influence and role model for her daughter.

Victim C said that on Thursday, April 4, at about 9:00 PM, she was in the kitchen with Victim A. Victim C explained that they had just gotten home from a soccer game and she saw a notification pop up on Victim A's phone (indicating that she had just received a text message). Victim C said that she was able to view a portion of the text message, and was surprised to see that the text message came from the Defendant. Victim C said that when she saw the text message was from the Defendant, she became *"instantly concerned."*

Victim C said that she took her daughter's phone and asked for the password. When provided, Victim C said that she spent about 5 minutes quickly looking through the text message thread before she asked her daughter if she had been having sex with the Defendant. Victim C said that the messages she did view briefly were "very sexual in nature" and that the Defendant was actually explaining various sex acts.

Victim C said that Victim B also looked through the phone, and the text threads, and they were both *"in shock as to what they saw and how a police officer could be saying these things to a high school student.*" At some point, Victim C said that Victim B went into their daughter's bedroom, and Victim B had a short conversation with her. Victim A denied having any sexual contact with the Defendant whatsoever. The following morning, the two of them decided to report this to Kewaskum High School Administration.

Interview of Victim B - Dad

Separately, Lt. Lichtensteiger interviewed Victim B on April 5, 2024. Victim B said that he also observed many of the same messages that the Defendant had been sending to his 18 year old daughter. He described them as *"very graphic and sexual in nature."* He said that he was stunned by the nature of their relationship, and he immediately knew that this relationship was not appropriate.

Interview of Victim A

After interviewing both her mother and her father, Lt. Lichtensteiger interviewed Victim A that same evening of April 5, 2024. She said that she first met the Defendant at the end of the 2022 – 2023 school year. She said that she started to eat lunch in his office. She said that she did not have a lot of friends to eat with, and someone suggested that she eat lunch in the school resource officer's office. Victim A said that the Defendant "was very friendly and often times there would be other students eating their lunch in his office as well."

Victim A said that she had no interaction with the Defendant over the summer of 2023, but she resumed lunches in his office at the start of her senior year, that fall of 2023. She said that this was a daily thing unless the Defendant had other lunch obligations.

Victim A that she grew more trusting and closer in her relationship with the Defendant that fall of 2023. She said that he treated her really well, and "she trusted him with her emotions and feelings more than most of her classmates." She said that the Defendant remained "professional" with her through the fall and end of 2023." She said that the two of them were close, but the conversations they had were primarily about her, and her schooling, and the problems she was having.

She said that their relationship evolved by the middle of January of 2024. She remembers being under a lot of stress with her school work, and her theater responsibilities. She said that around this time, she asked him to review some of her school work, and he returned the school work with his personal phone number with a note attached. A few days later, she sent him a text message, thanking him. She then said that "the messages started out slow but over time became more and more frequent." She said that these communications evolved from appropriate and professional to inappropriate and eventually sexual.

Victim A said that the conversations became more sexual, first, in person. She said that when they were in his office together, the Defendant once said, "screw it, I find you physically attractive." She said that this occurred during a lunch period when they were alone in his office. She remembers that this was around the end of February or the beginning of March.

She described how their text messages became more sexual and vulgar. She remembered how he sent her one text message indicating that he needed "good sex right now." She said that she would respond flirtatiously to him, as she liked the attention and was admittedly attracted to the Defendant. She said that these types of conversations occurred not only by text message but also in person, during his employment as a school resource officer, while she was a full time student there at the high school.

Victim A said that her and her family went on a spring break from <u>March 23, 2024 to March</u> <u>30, 2024</u>. She said that the Defendant sent her messages regularly while she was away. At one point, he sent her a picture of his clothed groin, with an erection. She communicated to him that she liked the message, so he sent her a short time later a photo of his exposed, erect penis. In response, she said that she sent him a photo of her bare breasts to the Defendant. He responded positively, and she indicated that she was flattered by the attention.

At some point that spring break week, the two of them sent text messages to each other about the Defendant's upcoming promotion to Lieutenant with the Kewaskum Police Department. Victim A said that there had been some prior in person discussions about her giving him "a blowjob." She said that they discussed her performing oral sex on him on April 2, 2024, in the Defendant's office, under his desk, after covering the office windows. Victim A said that when April 2, 2024 arrived, she didn't feel comfortable performing oral sex on him, so it never happened.

Victim A said that they discussed this oral sex happening the next day, instead, on April 3, 2024. She said that the Defendant made comments around this time about how he wanted to have penis to vagina sexual intercourse with her on or next to his desk.

Victim A remembers on April 3, 2024, during fifth period, when she was performing her "work at school" obligations, she was in the costume storage area of the school's theater. She said that her job was to organize and go through the costumes. This was a secluded area that others normally didn't have access to. In fact, students could only access this area if they had a key. She said that the Defendant sent her a text to confirm that she was alone. She said that a short time later, he arrived in the costume room and stood in the doorway.

She said that the two of them talked, but that he seemed to be acting different. He told her that she smelled good. She thought that this was odd based on how far apart they were standing at the time. She said that he mentioned how "we could hide behind that rack and have a heavy make out session." She said that he tried to convince her a number of different times, and mentioned that the school administration was not around. Ultimately, though, Victim A said that they never did have physical contact, either that day, or any day for that matter.

Ultimately, Victim A and Victims B and C all consented to a complete forensic download and analysis of Victim A's phone.

Interview of Witness A – Girlfriend

On April 10, 2024, Lt. Lichtensteiger and Captain Grinwald met with the Defendant's girlfriend, Witness A. This girlfriend was located also through the Defendant's same Text Now messaging platform. Witness A said that she knew what the police wanted to speak with her about. She said that in some of her messages with the Defendant, the Defendant mentioned Victim A.

Witness A said that she first met the Defendant on a cellphone application called "Fet." She said that they communicated on this app for a day or two before they moved over to more conventional text messaging. Witness A said that she used her conventional text messages, but the Defendant used "Text Now." Witness A said that he was explicit about why he was using this platform, as he didn't want his wife to see the text messages.

Witness A said that over time she learned that the Defendant was a police officer . Over time, he in fact told her that he was a school resource officer at Kewaskum High School. She remembers the first time that she met him in person, he was working a high school football

game. She talked about their separate relationship, and the details of that relationship. One detail, as it relates to this particular criminal complaint, Witness A recalled how the Defendant sent her a picture of him standing in front of what appeared to be a school bathroom, wearing his full duty uniform, holding the phone with his left hand, and holding and masturbating his penis with his right hand. Witness A said that the Defendant's face was visible in the photograph.

Witness A said that about two week ago, during spring break, the Defendant told her about text communications he was having with one of his high school students (identified here as Victim A). Witness A said that Victim A was 18 years old, and he said that he had previously received a picture from Victim A of her legs while she was at the beach. Witness A said that the Defendant also told Victim A to send him pictures of her nude breasts.

Witness A said that the Defendant told her the Tuesday after spring break was over that Victim A was "going to perform oral sex on [the Defendant] in his office." Witness A said that she was "kind of hurt by this, as [the Defendant] could not find time for her but was finding time for [Victim A]." When Tuesday came and went, she asked the Defendant how the blow job with Victim A was, and he said that it never happened.

Interview of Witness C – Lunch Lady

Captain Grinwald interviewed a former Kewaskum High School lunch lady who worked at the high school from 2017 to June of 2023. This lunch lady – Witness C – said that she remembers the Defendant starting as a school resource officer in 2022. She said that the two of them were talkative, and got along fine, until the Defendant's interactions with her became much more flirtatious and provocative.

Witness C recalled the types of sexual comments that the Defendant would make to her. In the lunch line, for instance, he would ask her for "extra jiz" when requesting extra sauce. He made other comments to her, like how she needed to "get laid" and how he had a friend who she could "hook up with." One time, when Witness C asked him about this friend, the Defendant admitted that it was him in fact who wanted to "hook up with her."

Witness C said that she left Kewaskum High School in June of 2023. She remembers how in September of 2023 the Defendant pulled her over in the Citco gas station parking lot. He said that he pulled her over because of an error on her vehicle registration, but Witness C was confident that no error existed. Witness C suspected that he pulled her over so he could learn what her address was. A couple of days later, Witness C remembers how the Defendant texted her a comment, like "I see your home would you like company." Witness C thought that this was especially odd in that the Defendant, while during working hours, wouldn't have any reason to be in the vicinity of her home, as her home was outside his standard law enforcement jurisdiction.

This text message made Witness C very upset. She told the Defendant that he crossed the line and he should never come back. The Defendant apologized, and they haven't communicated since.

Interview of the Defendant

On April 5, 2024, at about 7:45 PM, Lt. Lichtensteiger and Captain Grinwald spoke with the Defendant in the Police Chief's conference room. They both made it clear that the Defendant. was free to leave and he was not under arrest at any time. The Defendant knowingly and voluntarily spoke with both of them.

He said that "he wanted to provide a full explanation and said he has been under a lot of stress lately at home." He said that his wife is pregnant and her pregnancy was high risk. He said that he has felt like he was walking "on eggshells" because of the pregnancy. The Defendant said that he was employed by the Kewaskum Police Department, and has been assigned by that Department to work as a School Resource Officer at Kewaskum High School. He said that he was been assigned to this task since October of 2022.

He acknowledged knowing Victim A, and knowing that she is a senior at Kewaskum. He said that she regularly stops by his office and eats lunch in his office. He said that he uses his conversation with Victim A as "a stress release." He said that "he struggles to communicate with his wife about his stresses as she generally has her own that they try to work through first."

He admitted to giving Victim A his personal cell phone number in January or February of 2024. He gave Victim A his "Text Now" number, leaving it for her on an assignment he was reviewing or her. He said that he was attracted to her at this time but that wasn't exactly why he provided his personal phone number to her. He said that "he had grown closer to Victim A and knew she was going through some stuff." He wanted to be available whenever she needed him. It was his intent to be available to her "as she struggled with her mental health."

The Defendant acknowledged that their text messages evolved from there. He said that the two of them "talked about having sex...." At one point, he claimed that Victim A told him that she wanted to give him a blow job. He said that this never happened, but they talked about it. He believed that "they talked about him performing oral sex on her as well as they talked about hugging and kissing."

He said that he did send her one photo of his exposed penis on his cell phone to Victim A. He also received two images from her in return, one of her clothed, and one of her exposed breasts. He said that he received these from her while she was on spring break, in March of 2024.

The Defendant acknowledged that the two of them talked about receiving oral sex from Victim A for his promotion to Lieutenant. He said that he was promoted to Lieutenant on April 1, 2024. He said that the conversation started towards the end of the prior week she was on spring break. He said that he did not actually think that the oral sex would actually occur, however. Ultimately, he denied that they ever had sexual contact of any sort, at any time. He also couldn't remember any details about the costume room. He admitted to seeing her that afternoon in the costume room, but "he said it was not [specifically] to get a blow job from [Victim A]." He couldn't remember if he asked her to "make out" with him, but said "it could have happened." This was on April 2, 2024.

Ultimately, the Defendant did consent to a full download of his cell phone. Lt. Lichtensteiger noted in his report that the Defendant's phone "did not contain much of evidentiary value as all of his communications were via a web browser and stored through the platform, not on the device." Further, Lt. Lichtensteiger noted in his report that the web platform for Text Now messages normally is only accessible for around 7 days before those communications are erased or deleted.

Towards the end of the interview, the Defendant is aware that the Kewaskum School District pays a portion of his salary, and that therefore "he was a part of the school staff" at Kewaskum High School.

The Defendant provided police with access to his Text Now phone number and account. After accessing and reviewing these messages, Lt. Lichtensteiger noted in his report that "the messages located on Text Now correlated to the messages that Detective Goehring reviewing from [Victim A's] hone extraction."

Analysis of Victim A's phone

West Bend Detective Goehring assisted with the forensic extraction and analysis of Victim A's cellular phone. He observed about 9,147 text messages between Victim And the Defendant, between January 25, 2024 and April 5, 2024. Broadly speaking, Detective Goehring noted in his report that Victim A initially refers to the Defendant by his last name or "Dad or Daddy." Throughout the text messages, Detective Goehring notes that the Defendant "is constantly telling [Victim A] that he is attracted to her and how aroused [Victim A] makes him."

Detective Goehring notes that their text messages become progressively more sexual and graphic, about the types of sex acts that the Defendant wants to perform on her or the sex acts that he wants her to perform on him, while working in the School Resource Office at Kewaskum High School, or other areas within the High School.

Here are verbatim sections of some of those text messages shared between the Defendant and Victim A, beginning on March 23, 2024:

Defendant - 3/23/2024 9:14:29 PM(UTC-5) Ope, I'm complimenting you. Sorry, I'll stop. I'll go back to throwing you on the counter in the dressing room and burying my face between your legs.

Victim A - 3/23/2024 9:15:10 PM(UTC-5) We will see a blur that

Victim A - 3/23/2024 9:15:13 PM(UTC-5) About

Defendant - 3/23/2024 9:16:51 PM(UTC-5) Lmao! I know I know.

Victim A - 3/23/2024 9:18:01 PM(UTC-5) But a bj in your office seems like a great idea

Defendant - 3/23/2024 9:18:39 PM(UTC-5) It absolutely does!!!

Victim A - 3/23/2024 9:19:39 PM(UTC-5) If we put shades on your windows than I would most likely feel okay about giving you one

Defendant - 3/23/2024 9:31:00 PM(UTC-5) I can do that. But you also can't see my desk from the door, so if you were under there nobody would see you anyway.

Victim A - 3/23/2024 9:33:51 PM(UTC-5) But what if someone from the office comes and tries to see if your in there

Defendant - 3/23/2024 9:37:41 PM(UTC-5) I'll have the door locked and pretend I'm on the phone. So if they look in they'll quickly leave.

Victim A - 3/23/2024 9:38:24 PM(UTC-5) I think you will have a hard time staying quiet

Defendant - 3/23/2024 9:41:15 PM(UTC-5) Oh I'll be quiet enough. And have music on.

Victim A - 3/23/2024 9:55:54 PM(UTC-5) But you also say that your walls are paper thin

And later in the day on March 24, 2024:

Defendant - 3/24/2024 9:33:45AM(UTC-5) Oh hush!

Victim A - 3/24/2024 9:34:15 AM(UTC-5) Make me daddy

Defendant - 3/24/2024 9:37:30 AM(UTC-5) Crawl on my desk and I will

Victim A - 3/24/2024 9:37:54 AM(UTC-5) That's only if you fit

Defendant - 3/24/2024 9:41:57 AM(UTC-5) Oh I'll fit. I have no doubt about that!

Victim A - 3/24/2024 9:43:39 AM(UTC-5) I mean it's kinda tight and small

Victim A - 3/24/2024 9:43:43 AM(UTC-5) Sooooo

Defendant - 3/24/2024 9:46:42 AM(UTC-5) Mmmm I bet it is!!! But it'll still fit. I'll just go slow at first.

Victim A - 3/24/2024 9:48:05 AM(UTC-5) I think I won't be able to fit the whole 8 tho

Defendant - 3/24/2024 9:49:58 AM(UTC-5) Maybe, maybe not. I guess we'll just have to see. LOL.

Victim A - 3/24/2024 9:50:40 AM(UTC-5) I guess we will

Defendant - 3/24/2024 9:52:56 AM(UTC-5) Whyd you have to make me hard so early in the day?!

Victim A - 3/24/2024 9:53:38 AM(UTC-5) It's part of my job title

Defendant - 3/24/2024 9:55:14 AM(UTC-5) Oh really?? I didn't know you had a job title.

Victim A - 3/24/2024 9:56:19 AM(UTC-5) Yeah I do actually, perks of fucking the school's resource officer

Defendant - 3/24/2024 9:59:07 AM(UTC-5) So what exactly is your job title?? Victim A - 3/24/2024 9:59:54 AM(UTC-5) Official SRO fucker

Defendant - 3/24/2024 10:01:07 AM(UTC-5) Ooohhhhhhh. I like that title for you!

Victim A - 3/24/2024 10:01:58 AM(UTC-5) I know you do, unfortunately next year I gotta come back and fuck the new one too

Defendant - 3/24/2024 10:04:06 AM(UTC-5) Ummmm.excuse me?!?!?! I DON'T THINK SO!!!!

Victim A - 3/24/2024 10:04:46 AM(UTC-5) Why not!!??!? It's my job

Defendant - 3/24/2024 10:05:36 AM(UTC-5) Your job ends at the end of this school year.

Victim A - 3/24/2024 10:06:07 AM(UTC-5) Am I already fired?

Defendant - 3/24/2024 10:07:39 AM(UTC-5) NO!!! You're not fired. Your position is just being eliminated at the end of this school year.

Victim A - 3/24/2024 10:08:30 AM(UTC-5) You're not the one who determines this position! Are you just upset with someone else's hands an cock on my !!??

Victim A - 3/24/2024 10:08:32 AM(UTC-5) Me

Defendant - 3/24/2024 10:09:28 AM(UTC-5) Kind of yeah!! At least if it's the next SRO!!!

Victim A - 3/24/2024 10:11:31 AM(UTC-5) I'm sorry for your loss of the decision who gets to touch a body that's not yours or a body you have no control who or what touches it

Defendant - 3/24/2024 10:13:44 AM(UTC-5) Damn. I didn't say I controlled it or anything. Just that I'd be a little jealous if you came back and fucked the next SRO.

That's all. Sorry if that offended you.

From March 25, 2024:

Defendant - 3/25/2024 8:52:25 AM(UTC-5) My office is finally starting to come together!

Victim A - 3/25/2024 8:53:51 AM(UTC-5) Yay!! So basically it's ready to fuck me is what your trying to say

Defendant - 3/25/2024 9:04:17 AM(UTC-5) Defendant sent an unknown image to Victim A

Defendant - 3/25/2024 9:04:23 AM(UTC-5) I mean. my desk is already clear enough.

Victim A - 3/25/2024 9:04:58 AM(UTC-5) I see that

Defendant - 3/25/2024 9:05:13 AM(UTC-5) It will be even better by the end of the day

Victim A - 3/25/2024 9:05:33 AM(UTC-5) Meaning

Defendant - 3/25/2024 9:19:15 AM(UTC-5) Meaning it will be even more cleared off and we'll have more room

Victim A - 3/25/2024 9:19:40 AM(UTC-5) Ooooooo

Defendant - 3/25/2024 9:32:41 AM(UTC-5) Yeahhhhhh Iol

Victim A - 3/25/2024 9:56:55 AM(UTC-5) Hehe

Defendant - 3/25/2024 10:04:31 AM(UTC-5) How's your day going so far??

Victim A - 3/25/2024 10:07:32 AM(UTC-5) Victim A sent Defendant an unknown image

Victim A - 3/25/2024 10:07:36 AM(UTC-5) Take a guess

Defendant - 3/25/2024 10:09:00 AM(UTC-5) I.....absolutely.hate you right now.

Victim A - 3/25/2024 10:12:40 AM(UTC-5) No.... you actually don't you would actually fuck me hard against your fest right now

Victim A - 3/25/2024 10:12:44 AM(UTC-5) Desk

Defendant - 3/25/2024 10:14:16 AM(UTC-5) Ok. this is very true!!!

From March 27, 2024:

Defendant - 3/27/2024 11:13:49 AM(UTC-5) Meanwhile, I'll just be sitting here imagining you on top of my desk with your legs spread open.

Victim A - 3/27/2024 11:14:07 AM(UTC-5) With or without clothes

Defendant - 3/27/2024 11:14:43 AM(UTC-5) Either or. I'm not picky.

Victim A - 3/27/2024 11:14:56 AM(UTC-5) I see how it is

Defendant - 3/27/2024 11:15:17 AM(UTC-5) I'd like to say without clothes, but I didn't know if that was going too far.
